**PRESCRIPTION DRUG BENEFIT MANAGEMENT SERVICES**  
Addendum #1  
Questions and Answers

Q1: In RFP 3123, page 5, section 4 references the contract period as 5 years with 5 additional one-year extensions. The Alliant PBM 2024-2026 requests pricing for 3 years ending 2026. Can you confirm that 3-year pricing is requested on pharmacy (versus 5)?

**A1: *Correct, Alliant is requesting multi-year rates (admin fees, dental, vision rates, etc.) in a 3-year term.***

Q2: In the RCPS PBM RFP Questionnaire Template 2024-2026, Section 2.3.3:

- a. Is RCPS under a Transparent Pass-Through Pricing today across all channels (i.e., retail, mail, and specialty pharmacy)?
- b. Will a traditional pricing offer be accepted?

**A2: *a. Currently Traditional pricing.***  
***b. Traditional pricing is preferred.***

Q3: RFP 3123 states there is a grandfathered population of retirees. Are these retirees Medicare eligible and if so would you be willing to put them on a separate group Medicare prescription drug plan?

**A3: *Medicare eligible retirees are not offered benefits through RCPS. There was a class of pre-65 retirees that were offered access to the group plan with RCPS, but that was a closed class and that member is no longer enrolled.***

Q4: Can you please confirm the term of this contract? One document says this for a 5-year term + 5 additional one-year renewals and another document says this is for a 3-year term.

**A4: *Alliant is requesting multi-year rates (admin fees, dental, vision rates, etc.) in a 3-year term.***

Q5: Are you looking to move to pass-through pricing? Is pass-through pricing a requirement? If so, are you looking for pass-through pricing at retail and mail?

**A5: *Traditional pricing is preferred.***

Q6: The RFP document states that Proposal shall be signed by an authorized representative of the Offeror. Please confirm that this needs to be an original ink signature.

**A6: *Authorizing signature may be ink signature or electronic signature.***

Q7: Will you provide a non-PDF version of Addendum 4 RCPS PBM RFP Questionnaire Template 2024-2026?
